From the Treasurer: 'Bank Accounts & More'

Once the basket has been passed, a group treasurer needs to hold the collected funds. Many options are practiced, ranging from keeping the money in a cigar box under the treasurer's bed to a bank account. Each group must decide for itself what steps it wants to take to hold its funds. For small group treasuries, the cigar box may serve nicely, but for many groups a bank account will be more appropriate and lends itself to better record-keeping for those suggested periodic treasurer's reports to the group.

- For bank accounts, experience suggests it is usually best to not co-mingle a group's funds with the personal funds of any group member.
- Accounts are best established in the group's name, rather than the name of a group member, thereby eliminating confusion about ownership of the funds.
- Multiple signers (usually two) are suggested to remove funds from any account.
- Checking accounts may offer the most flexibility, providing an easy way of moving funds. Free checking is possible.
- There may also be differences between savings and commercial banks in terms of how "friendly" they are and the range of fees they may charge.
- Shop around. Ask other local groups about their banking experience.

Your banking professional should be able to help you select an appropriate account type, and to walk you through his/her institution's documentation requirements. Whichever account and bank options are selected, the members setting up the account will need to provide some ID. Since the Patriot Act was established, there is no such thing as being able to anonymously move funds through a bank for any reason.

If needed, a group can secure a Federal ID (EID/TID) number for its account. Visit http://IRS.gov, and download form SS-4 (fss4.pdf) and its filing instructions (iss4.pdf). You also can obtain this ID from the IRS over the phone. Having this ID can simplify opening the account, but will not relieve members from providing some personal information.

Some account types will pay interest. Each group must decide for itself how it feels about collecting interest on its funds. Many AA service groups (including your GSO/AAWS and Nassau Intergroup) do not see interest-bearing accounts as being in conflict with AA principles.

Also, your group may be called upon to provide bylaws to establish itself with some banks. I can provide sample by-laws upon request.
