FAQs About AA History from AAWs *

Q. — What’s the history of typical AA slogans like “First Things First” and “One Day at a Time”?

A. — We don’t have a great deal of information about the origins of AA’s slogans and acronyms, but we can provide some sharing and preliminary information. Many of these slogans, as with other practices in AA, were simply passed along verbally to other members, so it is impossible to know who started using them first. It is possible that some of the slogans may have originally stemmed from a part of the Oxford Group Movement language, but it could also be that they were original with Bill and Dr. Bob and the early members.

Members have always inquired as to the origins of various slogans, and it has always been difficult to narrow down; in our research, we discovered a letter written by former GSO Archivist, Frank M., dated 1989, who responded to a similar question that was posed to him. This was Frank’s response, “Your interest in the origins of ‘One Day at a Time’ is shared by many of us. Like hand-holding, however, it’s difficult to pin-point the exact ‘moment.’” That is the problem we find with most of our AA slogans, unfortunately!

We do know, however, that many slogans commonly heard have been around since the early days of the Fellowship.

In December of 1958 Ruth Hock (non-alcoholic), who was AA’s first secretary, wrote a response to a similar question concerning different slogans. In her reply Ruth wrote:

“... Bill [W.] and I first worked together in January 1936 when he had been sober just a little over one year and at that time ‘Easy Does It,’ ‘Live and Let Live,’ and ‘First Things First,’ were part of the daily conversation. They were also used in the very first drafts of the book, but probably only Bill himself could tell you where he picked them up . . .

“As far as I’m concerned all of the above were introduced into AA by Bill W. himself although not original with him.

“Some of these could have been used in Oxford Group meetings but there is no way for sure.”

In addition to Ruth’s response, page 220 of Bill W.’s biography, *Pass It On*, also addresses this topic:

“Some ‘AA saws’ were also used as long ago as the late 1930s: ‘First Things First,’ ‘Easy Does It,’ ‘Live and Let Live.’ Because these appear in the first edition of the Big Book (at the end of the chapter on ‘The Family Afterward’), it’s probable that the use of the slogans originated with Bill and that he brought them with him from Vermont – old saws with new teeth.”

Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority."

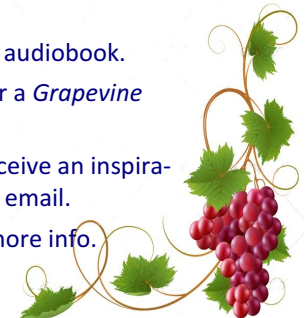

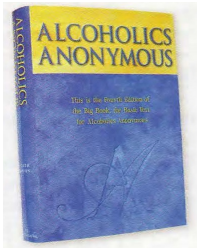

The Only Copy of the "Big Book"

This month Nassau Intergroup hosts its annual picnic in Eisenhower Park. On that occasion Alcoholics Anonymous will be on public display, each of us participating becoming perhaps the only copy of the "Big Book" a given member of the public may see. (Everyone around us may not know who we are, but many certainly will.) Any consideration or courtesy we show other users of the park, our respect for the park itself including how clean we leave the grounds when we go, will reflect on AA as a whole. Similarly, any misbehavior, any foul language we may use, not removing our cars from the grass when asked to, any trash we may leave behind when we go, will also reflect on all of AA.



Please keep this in mind as you enjoy yourself at our picnic. If we each mind our behavior and police our space before we leave (if you brought it in, either bring it out or place it in a proper trash receptacle when you leave), AA will be well represented.

The same holds true for how we handle ourselves in and around our local meeting places. I've been on hand as members cursed up a storm within earshot of a Rectory bedroom window, disturbed church neighbors, and when we left a trail of cigarette butts or coffee cups to mark our comings and goings. Groups have been asked to leave their meeting spaces, even after many years in a location, because of similar problem behavior. But it doesn't just reflect on those individuals or those meetings or groups. It reflects on AA as a whole because non-AAs do not distinguish between individual members—who we understand may still have recovery work to do—or our groups, or the fellowship as a whole or the program of AA. We reflect our principles in action or we do not. How AA is seen publicly impacts our ability to help the drunk who still suffers.

Northeast Regional Forum (Continued)—

The 2015 NERF was held at the Albany Marriott Hotel the weekend of May 29-31. I had the privilege of attending on behalf of Nassau Intergroup. There were approximately 440 AA members in attendance. The event was led by the newly elected Northeast Regional Trustee. We listened to some of our Class A and B Trustees. (There are 21 Trustees on the General Service Board, seven Class A, non-alcoholics, and 14 Class B, alcoholics.) A financial report was given by the General Service Board's Treasurer.

Presentations were also given by the *Grapevine* Executive Editor as well as the *La Viña* Editor. Ways to generate subscriptions were discussed such as giving a sponsee a subscription to the *Grapevine* as a first anniversary gift (in print \$28.97 or online \$34.97), also donating a subscription to an incarcerated alcoholic was suggested. Articles for inclusion in the *Grapevine* may be submitted by any AA member. Did you know that you can further support AA (other than through your home group's basket) with individual contributions on your anniversary or annually? Your Intergroup office has anniversary envelopes, but contributions may also be made online at www.aa.org. Bill W. wanted AA to always remain self supporting, and this responsibility lies with each and every one of AA's members. Discussed too was the fact that membership seems not to be growing. It is important that each group register with GSO in order to be included in AA's membership surveys every three years.

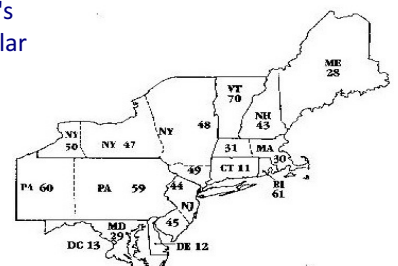
Staff members from the General Service Office talked about what was new at GSO (the New York City AA office on Riverside Drive). They also talked about their assignments and rotations (Each staff member rotates assignment every two years.) Our Trustee-at-Large/US gave a presentation on what AA is doing in other countries, "AA Around The World."

There were plenty of "Question & Answer" sessions throughout the weekend. Delegates from various areas spoke on topics such as, "How Do We Carry the Message Using Our Principles of Anonymity?," "Our Common Welfare – Who's Responsible?," "Service – You Can Pretend to Care," "How to Get People Involved in Service," "Freedom to Grow – AA's Warranties," and "Our Primary Purpose." It was inspiring to me to meet so many AA members who give so freely of their energy and time to ensure that AA continues to be around for all of us and the next generations of alcoholics.

Saturday evening was filled with various workshop sessions. I attended "Our Common Welfare - Who is Responsible?" about predatory and disruptive behaviors at meetings, and "Let's be Friendly with our Friends," who are our friends (doctors, nurses, social workers, law enforcement, librarians to name a few) and how to approach them to let them know that AA is available to them as a resource. As Nassau Intergroup's PI/CPC Chair, this was of particular interest to me.

Service is paramount to my sobriety. I am so grateful to have had the opportunity to attend NERF and to continue to be of service in Nassau County.

Answer to Who Am I?

First International Convention of Alcoholics Anonymous, Cleveland, Ohio, July 28-30, 1950. Although Bill W. would claim an attendance of 5,000, approximately 3,000 members and supporters were probably in attendance. Registration was \$1.50. On Saturday, Bill W. offered the shortened version of the "Twelve Points to Assure Our Future," the "Twelve Traditions" as a natural and essential corollary to the "Twelve Steps." There being no discussion on the Traditions, he then asked the assembly to formally adopt them which was done unanimously. The next day

Bill W. and Dr. Bob addressed the assembly. This was the occasion of "Dr. Bob's Farewell Talk." (See, *Dr. Bob and the Good Oldtimers*, pp. 74-55, and 337-338; and *Pass It On*, pp.333-334, and 338-342.)
